What's been happening on the Western Front

Camp Meeting, April 10th...

In April, we had Matt Knapp as our speaker. His subject was "Bill Wilson, the Real Josie Wales"

Bill Wilson didn't ride with Quantrill, he was a bushwhacker from Phelps County in the Ozarks, near Rolla Missouri. He maybe rode with Hildebrand's Raiders some of the time.

Wilson waged a one man war on the Jayhawkers. He was known for his skill, clever tactics, marksmanship.

Unlike the movie, his family wasn't killed. He was from a well to do family that tried to stay neutral. They had owned slaves but freed them well before the war. But, some horses were stolen in the area, and the Jayhawkers blamed Bill and burned his farm.

Bill was 6'2", nice looking guy and good natured. He played a fiddle and was always wanted at parties and events. He often practiced shooting from horseback.

After being accused of horse theft, Yankee bodies started turning up everywhere around there. At one place he shot 4 Yankees on a road. Bill started supplying stolen horses to Quantrill's men. Legend is Bill killed dozens of Yankees.

There was a \$300 bounty on bushwhackers. So Bill took his wife and 2 kids to Texas. His wife was part Cherokee.

After the war, Bill sold a wagon full of apples and was paid in Greenbacks. Two Ex Confederates turned Bounty Hunters were keeping an eye on Bill. After the sale they followed Bill, and they killed him.

I presume they stole the Greenbacks in that process. Both men were convicted and hung in Sherman Texas. But Bill survived the entire war, just to end up being killed by two former Confederate Soldiers.

The movie Outlaw Josey Wales was based on a book by Forest Carter called "Gone to Texas" The movie was released in 1976 and Clint Eastwood said it's his finest work. Clint Eastwood does have a Confederate relative, James McCallahan out of Virginia, that ended up in Missouri. The Movie is preserved in the National Archives and has been deemed historically significant.



In 2012, a crowd gathered at a music and arts festival to swing and gyrate along with the violent lyrics of "gangsta rap". The performance was given by Lesane Crooks, known by the pseudonym "Tupac", who appeared on the stage before his adoring fans. What made this performance unusual was that Crooks had been shot and

died in 1996, 16 years earlier. What the fans in the crowd viewed and reacted to was a hologram, a three-dimensional image formed by the manipulation of light waves. They knew Crooks was dead, but wanted to believe he was still performing and willingly acted in accordance with that belief.

It is said that seeing is believing, but what we choose to believe might not always be true. What we see, hear, and feel might not always be reality. False perceptions can originate from being told lies that violate our trust, permitting our own biases to enable us to sense what we choose, or following the crowd like sheep, accepting popular fads and prevailing points of view without questioning their veracity and verifying their factual basis.

In the past, sorcery or magic, from the Greek term mageia, and drugs, from the Greek term pharmakeia or pharmacy, were used to manipulate the mind and one's perception of reality. While the techniques have assumed modern methods, the mental deception they produce is the same and as old as time. The occult seeks to deal with metaphysical forces its practitioners believe govern physical elements to create the desire reality. Demonic activity is the real force at work. Practice of this has been discovered among American Indians, Africans, Sufi Moslems, Tibetan lamas, Zen Buddhists, Yoga, etc. Perhaps the oldest occult practices are associated with Hinduism, which teaches that the whole universe is an illusion created by the mind; one only needs to look within to the subconscious to discover one's real self and unleash latent unlimited potential psychic powers to create the truth and reality they choose.

Science and shamanism are merging. Once limited to dealing with physical laws pertaining to nature and the material world, scientists in Europe and America are incorporating metaphysics into science and saying that physical reality is a fabrication of the imagination and that the only

reality subsists in the thoughts of one's mind. Quantum mechanics is the mathematical system dealing with the behavior of atoms and molecules that compose matter. It is the study of the interaction of matter and radiation, energy in the form of light and heat sent out from the atoms and molecules that compose matter. Scientists are using their own terminology, but assigning occult meanings to the words. To state all of this scientific jargon bluntly, scientists are beginning to subscribe to the blasphemy that man, like God, supposedly has within himself the capability to create something out of nothing.

New Age philosophy is nothing more than Old Age occultism and it is pervasive like a disease permeating 21st century civilization. Many medical doctors, psychiatrists, psychologists, sociologists, theologians, educators, politicians, historians, even businessmen are either knowingly subscribing to or naively accepting this deception. Corporations train their employees, politicians fill their campaign rhetoric, educators indoctrinate students, and physicians believe health is just a state of mind. Theologians are reinterpreting scripture. God said, "Let Us make man in Our image..." (Gen. 1:26), meaning man is to be a mirror reflection of God 's glory to the world. New Age occultism reinterprets this to mean man is a god. A mirror reflects the image of the one before it; the image does not become what it reflects. Man can only be a channel of God's power; he has no latent divine attributes within himself waiting to be discovered and utilized.

Socialism in economics and medicine is being advocated in spite of the obvious advantage of capitalism. Youth are being told that their gender is merely a state of mind, contrary to anatomy and obvious common sense. Some are even identifying with animals instead of fellow humans. Miscegenation is being promoted on the superficial lie that our racial identity is only defined by skin color, ignoring the indelible code in our DNA. Homosexual unions are labeled marriage, changing the definition of what constitutes a valid marriage. Of particular concern to patriotic Americans and Southerners in particular is that historians are editing history by rewriting or omitting the record. and the real reason for the WBTS twisted. All these things are being done believing that one only needs to visualize their desires; reality is just a state of mind.



In April, Isaac Flanery was posthumously awarded the Southern Cross of Honor. It was presented to his relative, Dennis Flanery. And that made the paper in the Holden area! Isaac Flanery entered the Confederate William Colonel . Clarke Quantrill's Missouri Rangers during the fall of 1861. On the 12th day of August, 1862, he enlisted into the regular Confederate service as a private in William Clarke in Colonel Upton B. Hays's Regiment of General Joseph Orville Shelby's Brigade sworn into and the

the Confederate Army by States service as a part of Colonel Gideon W. Thompson.

Isaac Flanery Partisan fought in the 1st Battle of Independence, the Battle of Lone Jack and White Oak Creek, Cane Hill and Prairie Grove along with many other battles and skirmishes. Quantrill's company Flanery also fought at Lawrence, Baxter Springs, the Wagner Fight, the Battle of Fayette and Centralia

of Independence and the Battle of Westport and in Quantrill's winter campaign in Texas.

Awarded posthumously for having served with distinction until honorably discharged. The certificate read as follows:

Brigadier General John T. Hughes Sons of Confederate Veterans Essay Contest Rules

Essay subject: The Morrill Tariff as the Cause of the American Civil War

Contest is open to High School Juniors and Seniors who plan on attending college or a trade school after High School. Or to a student who is enlisting in a branch of the Military after high school.

Contest entries must be submitted typed double spaced, Times New Roman, 12 font, on 8 1/2' by 11" paper with 1" margins. Contest offered to High School Juniors or Seniors.

Essay Pages – The essay must:

Minimum of 800 and a maximum of 1,200 words (excluding title page, footnotes, bibliography page and biography. First page must include the Title. No applicant information on essay pages. No graphics, special covers or bindings are allowed. Essay must include a short applicant's autobiography, name, address and phone number.

Biography pages – The bibliography must:

Include a minimum of two references from either published works, encyclopedias or internet sources.

Judging: The essay will be judged for historical accuracy, clarity of thought, organization, grammar and spelling and the writer's summation and opinion of the topic.

Submission: Completed essays shall be submitted to the Brigadier General John T. Hughes Camp, Sons of Confederate Veterans or their designated representative on or before September 1, 2025.

Requirements: \$500 will be awarded for the winning essay. Winner will be required to accept the award at the monthly meeting of the Brigadier General John T. Hughes Camp on the second Thursday of the month located at Zarda BBQ at 6:00 pm in Blue Springs the month following notification of winning the award. Winner will agree to read their winning essay at time of awarding prize. All essays will become the property of the Brigadier General John T. Hughes Camp SCV. The winning essay may be submitted for publication in the Sons of Confederate Veterans newsletter. Applicants for the BGen John T. Hughes Essay agree that the decision of the judges is final and not subject for review.

Our next Missouri Division Reunion will be held March 27-28, 2026 in Carthage, MO.

We were honored to have as special guests SCV Commander-in-Chief Donnie Kennedy, SCV Executive Director Adam Southern, and SCV National Membership Director Eric Previti. Those in attendance had the opportunity to hear from, and converse personally with, these National SCV personalities.

This year's Friday evening Commanders' reception featured something unique: banjo and guitar music presented by Robert Adelson from the James Morgan Utz Camp and Hank Roberts from the General John T. Hughes Camp. Hank received the Missouri Division "John Moloski Friend of the SCV" award for 2025. There was no program on Friday night. Just music, finger foods, and fellowship. It was relaxed and casual. We have received lots of positive feedback about that.

Saturday morning's Missouri Division SCV business meeting commenced with our Color Guard honoring Missouri Southern soldiers. 15 of our 18 Missouri Camps were represented at this year's meeting. The Division general membership present at the meeting voted to add two new brigades to our large state by splitting Missouri into quadrants – Northwest, Southwest, Northeast, and Southeast - while keeping the Central Brigade. Liberty Battle Update

The National SCV General Executive Council has agreed to proceed with our appellate attorney Jonathan Sternberg's request to file a writ of prohibition in the Missouri Court of Appeals challenging the court order denying the SCV's claim and dismissing the SCV from the case. The National General Executive Council has also agreed to pay two-thirds of the cost to file the writ. This is in addition to the cost of appeal once a final judgement is rendered, should we be denied on the writ of prohibition. To do this, we as the Missouri Division are going to have to raise an extra \$3,000. However, there is also a chance we could be granted on the writ, which would mean the SCV is declared the owner of the property and allowed to defend, or at least being allowed to be a party in a jury trial. If denied, we will STILL appeal following the court's final judgement, expected early next year, no matter what. Either way, the Missouri Division will continue to stand on the principle that the SCV is the rightful owner of Block 174 in Fairview Cemetery in Liberty, where our gravemarker stands watch over our dead, as the legal heir of the United Confederate Veterans. Please state in the memo line what it is for. I hate asking for money from our members, but this is a long fight, and every dollar helps. Every day that monument in Liberty stands intact and undisturbed in any way at Fairview Cemetery is a victory. We will not yield an inch! This case is more than just about a single monument in a single cemetery in a single town. This is about the succession of United Confederate Veterans property to the Sons of Confederate Veterans, and could have national and long lasting ramifications. That is why we MUST win this in the end, no matter how long it takes.
