What's been happening on the Western Front

Camp Meeting, March 13th...

In March, we had Boyd Chapter Commander Steve Ferguson give us a presentation on Confederate Flags and we did a dedication ceremony of the new Boyd Chapter flag.

The First National Flag, which is called the Stars and Bars- the Rd fields stand for Valor and Fearlessness, the White field or stripe stood for Purity of a Christian Nation, and the Blue Canton stands for Justice and Determination. And the circle of stars represented the Confederate States, one star for each State.

The Second National Flag, nicknamed The Stainless- The white stood for purity of the cause, the Red canton stood for Justice and Determination, the Blue was for St Andrews Cross, and then the Stars were for each State.

The Third National Flag. Did not have a nickname. The white field was for Purity of Cause, The red tail was to show it was not a flag of surrender. That was the problem with the Stainless, of the field of battle at a distance it could have been confused as a surrender flag. The Red Canton was for Justice and Determition, then then Blue cross of St. Andrew, and the stars for the States.

The Missouri Society MOS&B has it's own flag. It's a mostly blue flag. The blue stands for Justice and Determination. It has the words Missouri Society to distinguish it from other State Societies, it has a badge in the center which represents Officers and Government officials of the CSA, it has the shape of Missouri which is Red standing for the Blood Shed of Missourians, and the 12 th star on the flag rpresents Missouri, which was the 12th State admitted to the CSA.

The new Boyd Chapter Flag is mostly Blue with a red St Andrew's cross. The blue is for Justice and Determination, the red cross for, missed a note on that, but probably Valor, the Red shape of Missouri is for Missouri Blood Shed, and the badge is trimmed in Gold to represent officers and elected officials.

Thanks to Steve for putting that all together and sharing this with us!

In Rom. 13:1-8, St. Paul delivers a brief treatise on the relationship of church and state. He begins by saying that we should "...be subject to the governing authorities." This applies even if those officials are not Christian. Next, he explains why. "For there is no authority except from God, and those that exist have been

instituted by God." When Pilate threatened Christ, He replied, "You would have no power over Me unless it had been given to you from above..." (Jn. 19:11) Paul continues, "Therefore he who resists the authorities resists what God has appointed..." Again, Paul explains why, "For rulers are not a terror to good conduct, but to bad." He further admonishes, "Then do what is good, and you will receive his approval, for he is God's servant for your good...to execute His wrath on the wrongdoers." Thus, the first purpose of government is to maintain order. The absence of order leads to chaos, totalitarianism to restore order, and the loss of freedom as a consequence. The second is to punish evil. It is wrong for citizens to riot and rebel sporadically over mere policy disagreements that are not based on just and moral reasons.

A problem arises. Public officials are fallible, so governments cannot be infallible. As a result, obedience to government is not absolute and unconditional. Paul adds an important factor. "Therefore, one must be subject...for the sake of conscience." If, after careful consideration, our conscience tells us that government is not doing the job God assigned it, to maintain order and punish evil, disobedience is permissible. When the ruling council charged Peter and the apostles not to teach the faith, they answered, "We must obey God rather than men." (Acts 5:29) Again, when the rulers and elders charged Peter and John not to teach, they answered, "Whether it is right in the sight of God to listen to you rather than to God, you must judge; for we cannot but speak of what we have seen and heard." (Acts 4:19) Christians have the same right and duty as the Maccabees who defeated Antiochus Epiphanes, the evil Syrian-Greek ruler, who forbad the worship of God. Finally, Paul advises, "Pay all to them their dues, taxes to whom taxes are due, revenue to whom revenue is due, respect

to whom respect is due, honor to whom honor is due." The Pharisees asked Christ, "Is it lawful to pay taxes to Caesar, or not?" Christ answered, "Render to Caesar the things that are Caesar's and to God the things that are God's." (Mk. 12:14)

The time when Paul wrote this letter to the Christians in Rome must be considered. Up to this point, both Christians and Jews experienced a certain degree of tolerance from the government that was a republic. The organized mass persecution of the church had not begun. Paul felt confident as a Roman citizen. This was all soon to change. The emperor, Nero, was evil. He killed his 14-year-old stepbrother, his mother he thought was a threat to his power, and his first and second wives. He blamed Christians for the burning of Rome. The church incurred the government's wrath when Christians refused to worship the emperor as a god.

During America's history, citizens have exercised their right to disobey government that had abdicated its ordained duty. The American Revolution rebuked George III for punishing virtue and rewarding injustice. The WBTS was the result of the CSA declaring its independence as the US did from England. The CSA did not disobey the law; it exercised its right to secede without violence from what was understood to be a voluntary union. Like England, the North committed many injustices to suppress the CSA. On 1/6/20, the US Capitol was attacked. It is now being asked if pardons for many of the participants are appropriate. Could the grievances have been expressed in a more constructive way? Was such violence justified?

Paul advised. "Owe nobody, except to love one another; for he who loves his neighbor has fulfilled the law." The love he alludes to is not eros, romantic emotionalism, but agape, freely and sincerely caring for the welfare of others without expectation of something in return. Obedience to this law and the laws of government should not be done only because of a sense of duty or fear. We should be able to do so because we freely choose to obey due to a sense of agape love for our fellow citizens and patriotism for our nation. The more this love controls our relationships, the more civilized our society becomes, and the less government we need. Instead of being monitored and limited by cameras, metal detectors, security guards, and locked doors,

Attached are the proposed amendments to the Missouri Division Constitution, to be voted on by the general membership present at the Missouri Division SCV Reunion Business Meeting on April 12 in Rolla.

Camp Commanders should be receiving the attached document within the next several days by U.S. mail, as required by our Division Constitution. It is to be mailed 30 days in advance of the Reunion, per Article XII of our Constitution.

Proposed Revisions to Missouri Division SCV Constitution

Proposed additions made in **bold**. To be voted on at business meeting at Missouri Division Reunion, April 12, 2025, Rolla, MO

Amendment 1 - Brigade Restructure

Adds to Article III, Section 1(b)

Article III-Organization Section 1(b):

"The Missouri Division, Sons of Confederate Veterans shall be geographically divided into five (5) Brigades consisting of the following:

[1] Northwest Brigade, which shall include the:

Major General J.O. Shelby Camp 191 – Warrensburg, Missouri General John T. Hughes Camp 614 – Independence, Missouri Surgeon John Cravens Camp 2276 – Gallatin, Missouri

[2] Southwest Brigade, which shall include the:

General James H. McBride Camp 632 – Springfield, Missouri Colonel John T. Coffee Camp 1934 – Osceola, Missouri Campbell's Company Camp 2252 – Republic, Missouri Major Thomas R. Livingston Camp 2327 – Carthage, Missouri

[3] Central Brigade, which shall include the:

Colonel Elijah Gates Camp 570 – Fulton, Missouri General M.M. Parsons Camp 718 – Jefferson City, Missouri Captain Moses J. Bradford Camp 2344 – Rolla, Missouri

[4] Northeast Brigade, which shall include the:

General Sterling Price Camp 145 – St. Louis, Missouri Major James Morgan Utz Camp 1815 – Florissant, Missouri Colonel Joseph Porter Camp 2055 – Shelbina, Missouri Brig. General Stand Watie Camp 2300 – St. Charles County, Missouri

[5] Southeast Brigade, which shall include the:

General M. Jeff Thompson Camp 2277 – Farmington, Missouri Stoddard Rangers Camp 2290 – Dexter, Missouri Private Bailey Brooks Camp 2335 – Cooter, Missouri Colonel Timothy Reeves Camp 2350 – Doniphan, Missouri

From the Desk of Missouri Division Commander Jeff Futhey continued..

Explanation: Adds two new brigades by splitting the Division into quadrants, while keeping the Central Brigade intact as is. The way we are structured now - Western, Central, and Eastern - with the lines drawn north to south down our rather large state is ineffective for a Brigade to actually function as we want it to. In the Western Brigade there are 211 miles between the northernmost Camp (Cravens) at Gallatin and the southernmost Camp (Livingston) at Carthage. In the Central Brigade there is 238 miles between the northernmost Camp (Gates) at Auxvasse and the southernmost Camp (Reeves) at Doniphan. In the Eastern Brigade there is an incredible 341 miles between the northernmost Camp (Porter) at Shelbina and the southernmost Camp (Brooks) at Cooter. This makes it very difficult for our Brigades to have any kind of cohesiveness, or regional unity. We want our Brigades to hold their own gatherings, for instance.. The way it is set up now, split north to south down our rather large State, this can be difficult logistically. If we are serious about reviving the Brigade system in the Missouri Division, splitting up the State is the only feasible way to do this.

 Proposed by Wes Franklin, Missouri Division Adjutant. Recommended for approval by the Missouri Executive Council on June 1, 2024.

Amendment 2 - Repayment to interest bearing account(s)

Adds the following section to Article IX

Section 11. If and when the Missouri Division Executive Council deems it necessary to withdraw funds from the interest bearing account(s), the Division must have in place a repayment plan to replenish the amount of funds withdrawn plus interest. The interest must be equal to or greater than that which would have accrued during the time frame said funds were in use. The repayment plan must be made available to all Executive Council members at least seven (7) days prior to any vote taken to withdraw funds from the interest bearing account(s). No further funds may be withdrawn from the interest bearing account(s) until the repayment has been made in full.

Explanation: The interest bearing account(s) is in place to guarantee that there is continued funding for the Missouri Division when Division Life Memberships are paid for by the Missouri Division. This helps supplement the dues paid by members on a yearly basis. Also, this continues after a Life member passes unlike when a member that pays yearly. At some point in time the incoming revenue from the money market will surpass the money incoming from yearly dues and this is a positive for the Division in its ability to accomplish its stated goals. We need a system of checks and balances in place to make sure that the money withdrawn gets returned plus the revenue lost in interest for that period of time.


